This is an overview of Congressman Case's leadership since 2019 on key bills, cosponsorships, votes, Appropriations Committee achievements, joint letters, statements and congressional delegations that advance Hawaii's and the nation's conservation of natural resources and public lands.

- <u>H.R. 6603</u>, the Ka'ena Point National Heritage Area Act. This bill directs the Department of the Interior to conduct a study to assess the suitability and feasibility of designating Ka'ena Point as a National Heritage Area.
- <u>H.R. 5506</u>, the Hawai'i Invasive Species Protection Act. This bill would require all cargo coming into Hawai'i to be inspected for invasive species.

Key Cosponsorships

He has consistently cosponsored legislation across multiple Congresses to advance long-standing priorities in the natural resources sector, including conservation, climate action and equitable access to public lands.

These have included key efforts to protect ecologically significant landscapes through measures such as the Roadless Area Conservation Act, the Boundary Waters Wilderness Protection and Pollution Prevention Act, the Northern Rockies Ecosystem Protection Act and the Arctic Refuge Protection Act. These place-specific bills underscore his dedication to preserving wilderness areas and safeguarding cultural and environmental heritage.

He has also repeatedly supported legislation to conserve wildlife and uphold the principles of the Endangered Species Act, including the Extinction Prevention Act, the Migratory Bird Protection Act and the Albatross and Petrel Conservation Act.

Recognizing the urgency of the climate crisis, he has cosponsored the *SAFE Act* and similar measures to strengthen national resilience and reduce greenhouse gas emissions.

Additionally, he has been a consistent advocate for improving public access and recreation opportunities through bills such as the Modernizing Access to Our Public Land Act, the EXPLORE Act and the Explore America Act, ensuring responsible stewardship and enjoyment of public lands for future generations.

Key Votes

His voting record reflects a consistent commitment to protecting bedrock environmental laws like the National Environmental Policy Act (NEPA) and the Endangered Species Act (ESA), which ensure that development proceeds responsibly and sustainably. He has also supported Hawai'i-specific legislation to safeguard local ecosystems, fisheries and cultural resources, recognizing the unique environmental and economic needs of the islands. In addition, he has backed measures that strengthen federal agencies' ability to manage and protect public lands while promoting responsible access and stewardship for future generations.

For example, the rule limited the use of off-road vehicles, such as off-highway vehicles and all-terrain vehicles, in certain areas.

- Voted YAY on H.R. 8219, the Lahaina National Heritage Area Study Act. This act directs the National Park Service to assess the suitability and feasibility of designating Lahaina, Maui County, Hawaii, as the Lahaina National Heritage Area under the National Heritage Areas Act.
- Voted NAY on <u>H.R. 7409</u>, the HEATS Act. This bill exempts certain geothermal activities on state and private lands (except Indian lands) from drilling permit requirements as well as environmental and historic preservation review requirements.
- Voted NAY on <u>H.Res. 987</u>, Denouncing the "harmful, anti-American energy policies" of the Biden Administration.
- Voted NAY on <u>H.R. 2925</u>, the Mining Regulatory Clarity Act. This bill sets forth a process to allow mine operations to use, occupy and conduct operations (e.g., construction of roads and other mining infrastructure activity) on public land regardless of whether a mineral deposit has been discovered on the land.
- Voted YAY on <u>H.R. 1567</u>, the ACRES Act. This bill requires the Department of Agriculture (USDA) and the Department of the Interior to submit accurate reports regarding hazardous fuels reduction activity.
- Voted NAY on <u>H.R. 1449</u>, the CLEAN Act. This bill requires the Department of the Interior to increase the frequency of lease sales under the Geothermal Steam Act of 1970 and establishes deadlines for consideration of geothermal drilling permits.
- Voted NAY on <u>H.R. 1121</u>, the Protecting American Energy Production Act. This bill prohibits the President from declaring a moratorium on the use of hydraulic fracturing unless Congress authorizes the moratorium. The bill also expresses the sense of Congress that states should maintain primacy for the regulation of hydraulic fracturing for oil and natural gas production on state and private lands.
- Voted YAY on <u>H.R. 897</u>, the Alabama Underwater Forest National Marine Sanctuary and Protection Act. This bill designates an ancient cypress forest in the Gulf of Mexico as the Alabama Underwater Forest National Marine Sanctuary under the Marine Protection, Research and Sanctuaries Act of 1972.
- Voted NAY on <u>H.R. 764</u>, the Trust the Science Act. This bill directs the Department of the Interior to remove protections for the gray wolf under the Endangered Species Act of 1973 (ESA). Specifically, the bill requires Interior to reissue the final rule titled *Endangered and Threatened Wildlife and Plants; Removing the Gray Wolf (Canis lupus) From the List of Endangered and Threatened Wildlife* and published on November 3, 2020.
- Voted NAY on <u>H.R. 615</u>, the Protecting Access for Hunters and Anglers Act. This bill
 bars the Department of the Interior and the Department of Agriculture from prohibiting or
 regulating the use of lead ammunition or tackle on federal land or water that is under the
 jurisdiction of such departments and made available for hunting or fishing.

117th Congress

• Voted YAY on <u>H.R. 7693</u>, the National Park Foundation Reauthorization Act. This bill reauthorizes through FY2030 the National Park Foundation.

- Voted YAY on <u>H.R. 7283</u>, the STREAM Act. This bill allows a state to set aside up to 30% of its annual grant for abandoned mine reclamation provided under the Infrastructure Investment and Jobs Act for the treatment and abatement of acid mine drainage, which is the release of acidic water from abandoned coal mines.
- Voted YAY on <u>H.R. 7025</u>, the Advancing Human Rights-Centered International Conservation Act. This bill requires the U.S. Fish and Wildlife Service (USFWS) to take actions to ensure that the international financial assistance it provides does not go to any foreign security force unit (e.g., a military or paramilitary unit) where there is a reasonable belief that the unit has committed a gross violation of internationally recognized human rights.
- Voted YAY on <u>H.R. 5118</u>, the Wildfire Response and Drought Resiliency Act. This bill
 provides for measures to mitigate wildfires, drought and other natural and human
 disasters.
- Voted YAY on H.R. 3113, the Modernizing Access to Our Public Land Act. This bill directs the Department of the Interior, the Forest Service and the U.S. Army Corps of Engineers to jointly develop and adopt interagency standards to ensure compatibility and interoperability among federal databases for the collection and dissemination of outdoor recreation data related to federal lands and used to depict locations at which recreation uses are available to the public.
- Voted YAY on <u>H.R. 2773</u>, the Recovering America's Wildlife Act. This bill provides funding for the conservation or restoration of wildlife and plant species of greatest conservation need, including endangered or threatened species and establishes related requirements.
- Voted YAY on <u>H.R. 803</u>, the Protecting America's Wilderness and Public Lands Act. This bill provides for the preservation, conservation and recreational use of public lands (establishes National Heritage Area system).

- Voted YAY on <u>H.R. 5040</u>, the AIR Safety Act. This bill directs the Bureau of Land Management to study the effects of drone incursions on the suppression of wildfires concerning lands managed by the Department of the Interior or the Department of Agriculture.
- Voted YAY on <u>H.R. 2546</u>, the Protecting America's Wilderness Act. This bill designates wilderness areas, potential wilderness areas, recreation areas, scenic areas, trails and wild and scenic rivers in Colorado, California and Washington, among other things.
- Voted YAY on <u>H.R. 1146</u>, the Arctic Cultural and Coastal Plain Protection Act. This bill
 prohibits the Bureau of Land Management from administering an oil and gas leasing,
 development, production and transportation program in and from the Coastal Plain of the

Appropriations

Through his assignment on the House Appropriations Committee, responsible for all federal discretionary funding, he secured the following successes for the State of Hawai'i.

- \$4.75 million for the State of the Birds Activities to respond to urgent needs of critically endangered birds.
- \$66 million for the U.S. Geological Survey's Climate Adaptation Science Centers, which includes the Pacific Islands Climate Adaptation Science Center based out of the University of Hawai'i Mānoa.
- \$1 million for the Fireshed Partnerships to Facilitate Wildfire Risk Reduction Project for University of Hawai'i at Mānoa (Community Project Funding).

Fiscal Year 2025
