

U.S. Representative Ed Case Women's Issues Legislative Accomplishments (2019-2026)

Hawai'i has a long and proud history of advancing women's rights, including as just one instance being the first state to ratify the Equal Rights Amendment in 1972. Hawaii's Congressional delegation has similarly pursued women's right on a national level, including as just one example U.S. Rep. Patsy Mink's pioneering work on Title IX.

Building on this kuleana, Rep. Ed Case has similarly championed policies to advance women throughout his service in Congress (2002-2007, 2019-present). His actions include sponsorship of measures, votes, funding, letters and statements, and litigation, especially against the current administration.

His primary advocacy over the last eight years has been through his membership on the U.S. House Committee on Appropriations, which is responsible for all federal discretionary funding. Gender-specific and women-related federal programs and initiatives are integrated across multiple appropriations bills, allowing Rep. Case to support funding across all twelve bills, from protecting reproductive rights to addressing violence against women and more.

Key Cosponsorships

Through his cosponsorships of proposed legislation, Rep. Case has worked with like-minded colleagues to consistently support women-focused legislation, programs and initiatives both nationwide and in our Hawai'i. Rep. Case has consistently cosponsored measures to protect reproductive rights, gender-based violence support programs and women-focused education initiatives across multiple Congresses.

- [H.R. 7973](#), the Momnibus Act. This bill package is a combination of 14 bills focused on comprehensively addressing factors impacting maternal mortality, morbidity and disparities in the United States.

- [H.R. 6677](#), the Professional Degree Access Restoration Act. This bill would restore federal student aid for professional degree programs that were excluded and to expand access to funding for students in pursuing those fields.

- [H.R. 5390](#), the Family and Medical Insurance Leave Act (FAMILY) Act. This bill would provide partial wage payment for workers on leave for qualifying medical or family reasons.
- [H.R. 4796](#), the Restoring Essential Healthcare Act. This bill would repeal the harmful provision in the recently enacted reconciliation budget bill that attempts to block Medicaid reimbursements to Planned Parenthood and other clinics providing abortion services.
- [H.R. 4611](#), the Equal Access to Abortion Coverage in Health Insurance (EACH) Act. This bill would repeal the Hyde Amendment and related provisions to guarantee abortion coverage for those who receive care through federally funded programs.

Key Votes

Rep. Case’s voting record supports for a wide range of women-focused issues, including the protection of reproductive rights, efforts that combat gender-based violence and the advancement of equal rights. He has also voted against harmful legislation in these same areas including those that would reduce or eliminate funding, programs or protections in these areas. As some examples:

- Voted YEA on H.R. 6644, the 21st Century ROAD to Housing Act. This bill would expand financing for affordable housing and increase the maximum eligible income for programs that provide grants for low-income housing.
- Voted YEA on H.R. 5201, the Kari’s Law Reporting Act. This bill would direct the Federal Communications Commission to report on the implementation of 911 access and compliance.

- Voted YEA on S. 3971, the Small Business Innovation and Economic Security Act. This bill would reauthorize funding for the Small Business programs that provide competitive awards for small businesses.
- Voted NAY on H.R. 28, the Protection of Women and Girls in Sports Act. This bill would amend Title IX to separate school sports teams based off of biological sex at birth.
- Voted NAY on H.R. 21, the Born-Alive Abortion Survivors Protection Act. This bill would require doctors to treat a baby born alive through abortion the same as any other newborn, or they face legal penalties.
- Voted NAY on H.R. 1, the budget reconciliation bill. This bill which not only included a provision blocking funding for Planned Parenthood but also delivered massive tax breaks to the wealthiest Americans while slashing Medicaid, the Supplemental Nutrition Assistance Program and other vital safety net programs.

Appropriations

Through Rep. Case's membership on the House Appropriations Committee, he has secured funding for various Hawai'i women-related programs. CPFs

- Safe Harbor Support for Housing Survivors of Domestic Violence Project
 - \$850,000 for the Hawaii State Domestic Violence Action Center’s housing program on O’ahu to support property acquisition and development to provide safe, affordable housing and supportive services for domestic violence survivors and their children.
- Pali Momi Medical Center Backup Generator Project
 - \$1.02 million request for funding to install a fixed generator at Pali Momi Medical Center.
- Outdoor Multi-Purpose Community Facility
 - \$940,600 for funding that would be used to provide an outdoor multi-purpose community facility that will support a wide range of activities. It supports meal distributions, special events, Young Athlete Play Days, fitness classes, blood

drives and other community events and services. The project would also include a gazebo and fencing, along with sports equipment and bleachers.

 - \$850,000 to renovate Hale Aloha, a 12-unit apartment building in Honolulu, to provide safe, stable, and affordable transitional housing for single mothers and families experiencing or at risk of homelessness by upgrading critical building systems and addressing major health and safety concerns.
- Feeding Hawai‘i Together: The Pantry
 - \$850,000 to renovate and improve the Food Pantry. Feeding Hawaii Together meets a compelling local need by serving individuals who are food insecure. The Pantry also has a proven track record – serving over 95,000 individuals in 2022.
- Big Brothers Big Sisters Hawai‘i: Headquarters Building
 - \$850,000 for new headquarters to provide space for its youth programs, support community and family workshops and act as a hub for mentoring services.
- YMCA Youth Wellness Program for Mental Health
 - \$275,000 for the YMCA Youth Wellness Program for Mental Health, which will serve 450 youth ages 12 to 18 through accessible after-school experiential and therapeutic sessions that build self-awareness, coping skills, stress management, and emotional wellness while connecting participants to appropriate mental health resources and support services.
- Village of Redemption
 - \$500,000 for The Institute of Human Services’ Village of Redemption Re-Entry Program, which will support the renovation of six homes to provide safe, stable housing for recently released individuals on O‘ahu, helping address homelessness and reduce recidivism by improving access to supportive re-entry resources.
- Leeward Community Small Business Incubator
 - \$500,000 for the Institute for Native Pacific Education and Culture (INPEACE) to the Leeward Community Small Business Incubator Project that will expand access to critical business development services and technical assistance for small businesses and entrepreneurs in West O‘ahu, particularly within Native Hawaiian and veteran communities.
- Hale Laele Indigenous Health and Education Center
 - \$1.05 million to Kōkua Kalihi Valley Comprehensive Family Planning Services to construct a 7,500-square-foot facility at Ho‘oulu ‘Āina to advance indigenous-focused health and education by integrating traditional Native Hawaiian healing practices into community health training and clinical care programs.
- Workforce Resilience Initiative
 - \$975,000 to the State Libraries and Hawai‘i Literacy initiative, to provide digital literacy and workforce training to up to 8,000 residents through computer classes and online learning resources aimed at building technology and problem-solving skills statewide.
